- By purchasing Lithium batteries, the buyer assumes all risks associated with lithium batteries.
- Lithium batteries may explode and cause fire if misused or abused.
- Follow our instructions exactly listed in the product manual and the below.
- Do not charge the battery unattended. Do not charge the battery at temperatures less than 0 deg C (32 deg F). Charging at temperatures less than freezing, may cause fire. Charge batteries with only compatible lithium chargers. Do not use chargers designed for Lead Acid, NiCd, NiMh batteries. Using an incorrect charger may cause fire.
- Do not charge lithium batteries near gasoline, motor oil, or diesel fuel or if these fumes are detected, such as in a garage. Any charge current from the wall charger, if in contact, with combustible fuel or fumes will cause fire.
- When charging a lithium battery, please put the battery on a glass, plastic, or concrete surface. Do not charge a battery pack and charger on wooden surfaces or carpet, unattended.
- Do not run over the battery with a vehicle, tractor, or other machines. This will cause damage and cause fire.
- **Never charge batteries unattended.** When charging lithium batteries you should always remain in constant observation to monitor the charging process and react to potential problems that may occur.
- Never drop the batteries. In the event that the battery is dropped on a hard surface or due to mishandling during shipment or for any other reason the battery is dropped, remove the battery for observation and place in a safe open area away from any combustible material for approximately 15 minutes. Do not charge the battery if the battery was dropped on a hard surface or if damage is noticed on the battery.
- Set the charging voltage and charging current correctly (failure to do so can cause fire).
- Keep lithium batteries away from children
- Do not make a wrong polarity connection when charging and discharging lithium battery packs. Always double check polarity of battery's connector to make sure red wire to red wire and black wire to black wire.
- Never mix and use old lithium batteries in combination with new lithium batteries, or batteries with different brand names.
- Lithium batteries have a cycle life, please replace old batteries with new ones when it reaches its service life or when it is two years old, whichever comes first.
- Some 3rd party chargers on the market have technical deficiencies that cause it to charge the lithium batteries incorrectly or at an improper rate. It is your responsibility to ensure the charger you purchased works properly. Always monitor the charging process to ensure batteries are being charged properly. Failure to do so may result in fire.
- If at any time you witness a battery starting to balloon, swell up, smoke or get hot, discontinue the charging process immediately, disconnect the battery from the charger and observe it in a safe place for approximately 15 minutes. This may cause the battery to leak, and the reaction with air may cause the chemicals to ignite, resulting in fire.
- Since delayed chemical reaction can occur, it is best to observe the battery as a safety precaution in a safe area outside of any building or vehicle and away from any combustible material.
- Wire lead shorts can cause fire. Do not short the red and black connectors. If you accidentally short the positive and negative wires, the battery **must** be placed in a safe area for observation for approximately 15 minutes. Additionally, if a short occurs and contact is made with metal (such as metal rings on your fingers or other jewelry), severe injuries may occur due to the conductibility of electric current.
- Do not short circuit the battery, place it in a safe open space and observe the battery for approximately 15 minutes. A battery may swell or even possibly catch fire after a short time.
- Never store or charge a battery inside your car at temperatures less than 0 deg C (32 deg F) or temperatures exceeding 60 deg C (or 143 deg F), since these extreme temperatures can cause fire.
- We suggest you put the battery in a plastic or metal enclosure to protect it from damage from rain or dropping from a height accidentally.

Charging Process

- Never charge batteries unattended.
- Put the battery on a glass, plastic, or concrete surface and charge in an isolated area, away from other flammable materials. Always have a "ABC" type fire extinguisher in your facility, home, garage or other location for emergency use.
- Let the battery reach a temperature greater than 0 deg C (32 deg F) to a max of 60 deg F (143 deg F) for charging.
- **Do not charge batteries packs in series.** Charge each battery pack individually. Failure to do so may result in incorrect battery recognition and charging functions. Overcharging may occur and fire may be the result.
- You must ensure that the charge rate current does not exceed the battery's allowed charging current. (Please double check the battery's user manual)
- Temperature for Charging: Charge the battery only above 0 deg C (32 deg F), but no more than 60 deg C (140 deg F).
- Temperature for Discharging: Discharge the battery at temperatures from -20 Deg C (-4 deg F), but no more than 60 deg C (140 deg F)

Storage & Transportation

- Store batteries between 10 deg C to 30 deg C (50 deg F to 86 deg F).
- Do not expose battery packs to direct sunlight (heat) for extended periods.
- When transporting or temporarily storing in a vehicle, temperature range should be greater than-6 deg C to 65 deg C (20 degrees F to 150 degrees F max).
- Storing lithium batteries at temperatures greater than 65 deg C (150 degrees F) for extended periods of time (more than 2 hours) may cause damage to the battery and possible fire.

Life

Batteries that lose 20% of their capacity must be removed from service and disposed of properly. Discharge the battery to 3V/Cell, making sure output wires are insulated, then put the battery in a plastic bucket for disposal.
